Course: *E0273 Managing Floodplain Development through the National Flood Insurance Program*

This course is 4 days in length.

Emergency Management Institute (EMI)

Course Description:

This course provides an organized training opportunity for local officials responsible for administering their local floodplain management ordinance. The course will focus on the National Flood Insurance Program and concepts of floodplain management, maps and studies, ordinance administration, and the relationship between floodplain management and flood insurance.

Course Goals:

1. Describe important aspects of basic floodplain management practices necessary to begin a participant's floodplain management career.
2. Explain the range of topics necessary to manage a locally based floodplain management program including, providing outreach to citizens and officials to help them make informed decisions about flood hazards. Using Flood Insurance Studies and maps to determine the flood hazard risk at given sites. NFIP minimum floodplain criteria/management regulations.

Appropriate Letters of Map Change (LOMCs) for specific circumstances and the LOMC process. Requirements for a basic floodplain permit process including the FEMA elevation certificate and other certificates needed for floodplain management purposes. Technical assistance and creative solutions to mitigate flood hazards. Basic concepts of flood insurance rating, and legal implications of floodplain regulatory actions

Target Audience:

Local officials responsible for administering local floodplain management ordinances, including but not limited to floodplain management administrators, building inspectors, code enforcement/zoning officers, planners, city/county managers, attorneys, engineers, and public works officials. Federal and State floodplain managers are also encouraged to attend. The course is designed for

officials with limited floodplain management experience. Participants should have less than 3 years of full-time experience in the field of floodplain management.

To Apply:

Complete a FEMA Form 119-25-1, General Admissions Application, with student signature and signature of supervisor or sponsoring agency official. State and local participants must submit their application through the State Emergency Management Training office. Tribal representatives can submit their application directly to NETC Admission Office. FEMA Regional employees should submit their application to their Regional Training Manager (RTM).
